
WINTER OPERATIONS

FEDERAL UPDATE

- FY 2018 OMNIBUS APPROPRIATIONS BILL WAS SIGNED BY THE PRESIDENT
- ADMINISTRATION'S INFRASTRUCTURE PLAN UNLIKELY TO PASS THIS YEAR DUE TO MID-TERM ELECTIONS AND PASSAGE OF FY 18 BUDGET



JOINING FORCES FOR SAFETY

- CARSON CITY SHERIFF'S DEPARTMENT CONDUCTED AN OPERATION AT THREE INTERSECTIONS TO EDUCATE DRIVERS ON PEDESTRIAN SAFETY


- FORUM HELD BY THE NEVADA WATER INNOVATION CAMPUS APRIL 3RD IN SPARKS

- AWARD OF I-80 REPAVING PROJECT, KEYSTONE TO CA/NV STATE LINE, TO Q&D CONSTRUCTION IS BEFORE THE TRANSPORTATION BOARD TODAY (\$42.6 M)





USA PARKWAY ELECTRIC AVE. TRAFFIC SIGNAL UPDATE

- UTILITY RELOCATIONS HAVE COMMENCED (NV ENERGY POWER POLE, TWO FIRE HYDRANTS, SWITCH, AT&T AND CHARTER COMMUNICATIONS)
- CONTRACTOR WILL SUPPLY FLAGGERS TO DIRECT TRAFFIC DURING PEAK COMMUTE TIMES IN THE INTERIM
- TRAFFIC DETOUR FOR EB BRITAIN DR. TRAFFIC TO USA PARKWAY VIA WALTHAM WAY
- REDUCED SPEED LIMIT ON USA
 PARKWAY
- PURSUING TEMPORARY SIGNALS
 NEAR THE INTERCHANGE

- AWARD IS BEFORE THE TRANSPORTATION BOARD UNDER ITEM #7
- NDOT WILL ALSO CONSIDER ALTERNATIVE ACCESS TO TRIC UNDER THIS STUDY (SUCH AS THE LA POSADA ALTERNATIVE FROM EAST SPARKS)



RENO SPAGHETTI BOWL UPDATE

- DIRECTOR MALFABON AND ASST. DIRECTOR MORTENSEN MET WITH THE AIRPORT CEO MARILY MORA, AN AIRPORT BOARD MEMBER AND SENIOR AIRPORT STAFF TO DISCUSS THEIR DESIRE TO KEEP THE DIRECT ACCESS RAMPS IN THE FUTURE
- PROJECT MANAGEMENT STAFF MET WITH AIRPORT STAFF AND THEIR ENGINEERING CONSULTANT AFTER THE MEETING TO DISCUSS CONCEPTS
- NDOT WILL CONTINUE THE DISCUSSION IN THE COMING WEEKS



INDEPENDENT PROJECT SOUTH OF RENO SPAGHETTI BOWL

- PROJECT TEAM HAS DETERMINED THAT AN INDEPENDENT PROJECT FOR WIDENING I-580
 SOUTHBOUND LANES SOUTH OF THE INTERCHANGE TO VILLANOVA IS FEASIBLE
- ONLY ONE PARCEL WOULD HAVE TO BE ACQUIRED
- RTC WASHOE AND FHWA ARE GENERALLY SUPPORTIVE OF THE CONCEPT

PROJECT BENEFITS

- PROVIDES TWO LANES FOR EASTBOUND I-80 TO
 SOUTHBOUND I-580 MOVEMENT (RECONSTRUCTS I-580
 BRIDGES OVER THE TRUCKEE RIVER BRIDGE AND UPRR)
- WIDENS I-580 SOUTHBOUND TO VILLANOVA
- THIS INDEPENDENT PROJECT DOES NOT AFFECT RENO AIRPORT DIRECT CONNECT RAMPS
- THIS PROJECT IS COMPATIBLE WITH FUTURE SPAGHETTI BOWL INTERCHANGE IMPROVEMENTS
- DOES NOT DELAY SPAGHETTI BOWL NEPA; THIS IS AN INDEPENDENT PROJECT

INDEPENDENT PROJECT SOUTH OF RENO SPAGHETTI BOWL

ANTICIPATED ACTIONS:

- NDOT PRESENTATION TO TRANSPORTATION BOARD ON MAY 14, 2018 TO PROVIDE DETAILS AND SCHEDULE; RECEIVE BOARD APPROVAL TO PROCEED
- DEVELOP SFY 2019-2020 BIENNIAL BUDGET REQUEST TO GOVERNOR'S FINANCE OFFICE WITH APPROPRIATE BONDING ASSUMPTIONS
- PURSUE FORMAL APPROVALS FROM FHWA AND OBTAIN NEPA CLEARANCE
- AMEND RTC WASHOE REGIONAL TRANSPORTATION IMPROVEMENT PROGRAM (RTIP)
- ADOPT THE RTIP INTO THE STIP
- AMEND CONTRACT WITH CURRENT CONSULTANT TO SUPPORT DEVELOPMENT OF AN INDEPENDENT DESIGN-BUILD PROJECT
- ISSUE A REQUEST FOR QUALIFICATIONS (RFQ) FOR DESIGN-BUILD TEAMS AND ISSUE A DRAFT REQUEST FOR PROPOSAL FOR INDUSTRY REVIEW
- SUBJECT TO APPROVAL OF BONDING IN NDOT BIENNIAL BUDGET REQUEST



SOUTHERN NV PROJECTS

- I-11 PHASE 1 IS EXPECTED TO OPEN TO THE US 95 INTERCHANGE THIS MONTH
- BLUE DIAMOND ROAD PHASE 2 WIDENING AND REPAVING BIDS ARE DUE APRIL 12TH (\$59 – 71 MILLION RANGE); WE ADDED A STEEL ESCALATION CLAUSE TO THE CONTRACT DUE TO CONCERNS WITH VOLATILE PRICES RELATED TO POSSIBLE STEEL TARIFFS

- NO SETTLEMENTS AT APRIL 10TH BOE
- SETTLEMENT WITH TOMAHAWK LLC TO BE APPROVED AT MARCH 13TH BOE
 - \$3,330,000 FOR APPROXIMATELY 3.5 ACRES;
 (\$1,372,625 ADDITIONAL FROM AMOUNT PREVIOUSLY DEPOSITED WITH COURT
 - PROPERTY FOR STARR INTERCHANGE AT I-15
 - OPPORTUNITY FOR SALE OF ABOUT 2 ACRES OF SURPLUS PROPERTY UPON PROJECT COMPLETIO
