Thank you for attending this informational meeting regarding the Nevada Department of Transportation's (NDOT) Ely Roadway Reconstruction project. Project elements include roadway reconstruction, lane reconfiguration, drainage and utilities improvements, traffic signal improvements, lighting and aesthetics features, and pedestrian safety enhancements. The purpose of the project is to improve roadway conditions throughout the project area, alleviate flooding during storm events, upgrade water and sewer facilities, and enable safe access for all roadway users.

This meeting will be open-house format from 4 to 7 p.m. Project representatives will give a brief presentation beginning at 5:30 p.m., followed by a short question and answer period from the audience. The presentation and public comment period will be recorded by a hired court reporter.

As you enter the room, you will notice displays describing the project. Project representatives will be located at the displays. Please take this opportunity to ask questions and discuss the project with them.

During this meeting, as well as any public meetings conducted by NDOT, we are seeking your input. At today's meeting there are several ways you may give us your comments for the public record. Exhibits you wish to submit as a part of the public record of this project will be accepted.

<u>First</u>: During the open-house meeting, you may make an oral statement to the court reporter who will be available throughout the entire meeting.

<u>Second</u>: You may fill out the comment form attached to this handout and deposit it in the comment box or give the completed form to one of the project representatives.

<u>Third</u>: The public meeting record will remain open for two weeks following this meeting. If you would prefer to write a letter or mail your completed comment form and any exhibits, these will become part of the official transcript of the proceedings if mailed to John Bradshaw, NDOT, 1263 South Stewart Street, Carson City, NV 89712, and received by **5 p.m., Friday, July 27, 2018**.



Ely Roadway Reconstruction Project July 2018





Project Description

The Nevada Department of Transportation (NDOT) and the City of Ely are reconstructing deteriorated local roadways and upgrading the city's water and sewer facilities. US 50 from Ruth to the Ely city limits will receive roadway rehabilitation and shoulder stabilization. Within the city, the following improvements will be provided:

- Roadway reconstruction
- Lane reconfiguration
- Americans with Disabilities Act (ADA)/sidewalk/curb and gutter improvements
- Lighting
- Flashing beacon pedestrian crossings
- Aesthetics
- Drainage improvements
- Water and sewer pipeline replacement
- Fiber optic installation
- Traffic signal improvements

Tentative Project Schedule



Project Updates

NDOT has completed preliminary project design to the intermediate stage and is working on plans and specifications, in preparation for the quality assurance/quality control submittal. As design efforts progress, here is an update on utility and survey work:

COMPLETED

- Trenching across roadways to identify and survey utilities
- Ground-penetrating radar and survey of existing utilities
- Ground-penetrating radar and survey of historical underground features
- Video of sewer and storm drain facilities

ONGOING


- Coordination with utility owners to mitigate conflicts
- Potholing (utility identification) and survey (anticipated completion by the end of October, 2018)
















Traffic: "Road Diet"













Proposed Storm Drain Improvements

 Most storm drains within the project limits will be improved to meet current NDOT design standards

 A major storm drain is proposed from Courthouse Park to where Murry Creek crosses the railroad

Why the Improvements?

To reduce maintenance cost and time tending to outdated and degrading storm drain systems within the city limits

Why the Improvements?

- Reduce impacts to Aultman Street during future floods
- Expect a reduction of the flood limit extents due to improved hydrologic modeling and improved system conveyance




