

TRANSORTATION NOTICE PUBLIC INFORMATION MEETING FOR



Tropicana Avenue Phase II Resurfacing and Pedestrian Improvements

PURPOSE OF MEETING: In the spring of 2019, Nevada Department of Transportation (NDOT), will be making safety and road improvements to the East Tropicana Avenue corridor, from Las Vegas Boulevard to Boulder Highway. This meeting is to inform the traveling public about the scope of the project and details regarding roadway enhancements, night time lane restrictions in milling areas, temporary sidewalk and driveway closures, and travel delays along the corridor.

This project scope will involve:

- Milling and paving the road surface from Las Vegas Blvd to Eastern Ave
- Construct new median islands from Koval Lane to Eastern Avenue
- Update pedestrian facilities from Las Vegas Blvd. to Boulder Highway

PROJECT BENEFITS: The goal of this project is to improve safety and connectivity for all road users:

- Enhance safety by reconfiguring median islands to increase lane widths and reduce accidents resulting from left turns at minor cross streets
- Restore outside lane damaged by heavy bus traffic from Eastern Avenue to Boulder Highway
- Reconstruction of pedestrian facilities: sidewalk and driveway ADA ramps
- Resurface existing roadway
- Replace camera detection system with interconnect ground detection loops to reduce traffic flow delays
- Installing fiber optic cable throughout the corridor to improve signal phasing
- Replacing street lights fixtures and with LEDs

WHERE YOU COME IN: The meeting is designed to accommodate the public's schedule. Please attend at your convenience any time during the meeting hours of 4 to 7 p.m. Project representatives will be on hand to discuss and answer your questions and listen to your concerns. There will be a brief project presentation at 5:30 p.m., followed by a short question and answer period from the audience. Before and after the presentation, the meeting will be conducted as an open-house format to provide an opportunity to view displays and individually discuss the project with representatives. At the meeting, your comments may be submitted for public record in writing or verbally to a court reporter, who will be available throughout the meeting. (A Spanish translator will be available during this meeting.)
