- 2. Roll call of NBPAB members**
- 3. PUBLIC COMMENT AND CITIZENS PARTICIPATION:** No action may be taken on any matter discussed under this item that is not listed on this Agenda, although the NBPAB can direct that such items be placed on a future agenda.

At this time, any citizen in the audience may address the NBPAB on any matter. No vote can be taken on a matter not listed on the posted agenda; however, the NBPAB can direct that the matter be placed on a future agenda.

Each citizen must be recognized by the Chairperson. The citizen is then to approach the microphone to state his or her name, and to spell the last name for the record. The Chairperson may limit remarks if such remarks are disruptive to the meeting or not within the NBPAB's jurisdiction.

The Nevada Department of Transportation keeps the official record of all proceedings of the meeting. In order to maintain a complete and accurate record, copies of documents used during a presentation must be submitted to the Recording Secretary.

The Nevada Bicycle and Pedestrian Advisory Board appreciates the time citizens devote to be involved in this important process.

Public comment is limited to 5 minutes per person.

Agenda items may be taken out of the order presented on the agenda at the discretion of the chairperson. The Board may combine two or more agenda items for consideration. The Board may remove an item from the agenda or delay discussion relating to an agenda item at any time. The Board may make reasonable restrictions on time, place, and manner but will not restrict the comments based upon viewpoint.

4. **Approval of the July 19th, 2018 minutes (for possible action)**
Action may be taken to approve the July 19th, 2018 meeting minutes.

General Meeting Items.

Presentations are limited to 10 minutes per presenter.

5. **Lake Tahoe Region Safety Plan Morgan Beryl – Tahoe Regional Planning Agency (for possible action)**

The Lake Tahoe Region Safety Plan is being developed to implement recommendations to improve roadway safety for the region. This plan will benefit vehicles, trucks, as well as non-motorized users, and work towards achieving the Metropolitan Planning Organization's transportation goals. An overview of the proposed plan will be presented. Action may be taken to provide an advisory recommendation regarding the proposed Lake Tahoe Region Safety Plan.

6. **Ely complete streets. NDOT Roadway Design (for possible action)**

Complete Streets design is an approach used within the transportation industry to develop street networks that function for all users. An overview of the status of the proposed complete streets project for the Town of Ely will be presented. Action may be taken to provide an advisory recommendation regarding the proposed Ely project.

7. **Election of the Nevada Bicycle and Pedestrian Advisory Board Interim Vice Chairperson (for possible action)**

The Nevada Bicycle and Pedestrian Advisory Board annual elections are held at each January meeting. The current vice-chairman will be leaving the NBPAB effective September 30, 2018. Action may be taken to elect an interim vice-chairperson for remainder of the 2018 term until the annual elections in January, 2019.

8. **Report on Recreational Trails Program and Land and Water Conservation Fund update. Janice Keillor**

The federal government makes discretionary funding available to states which can be used for recreational trail projects and programs. These funds are available to local entities via a competitive state funding programs administered by the Nevada Division of State Parks. An update on the status of these funding programs will be given.

9. Discussion of legality of bicycles and scooters on sidewalks *Ron Floth (for possible action)*

Nevada law does not specifically authorize nor prohibit the operation of a bicycle upon a sidewalk; however, local government entities may enact their own ordinances or municipal codes regarding a prohibition. A matrix of known ordinances and laws will be presented.

10. Report on Share the Road Specialty License Plates and Grant Program *Albert Jacquez (for possible action)*

The NBPAB developed a “Share the Road” specialty license plate to provide additional funding for local bicycle and pedestrian initiatives throughout the state. Funds are made available through a competitive grant process administered by the NDOT. An update of available plate funds, and status of the 2019 grant cycle, will be given.

11. Electric Bicycle Overview *Jon Anderson - LimeBike*

Bicycles equipped with small electric motors have emerged as a growing industry trend over the last few years. These conveyances were recognized under Nevada law in 2009. While their share of the industry market is still small, their introduction has brought to light a number of issues, concerns, and opportunities, whether perceived or real, related to their place in transportation and recreation systems. An update on the state of this segment of the bicycle industry will be given.

12. Reports from the Bicycle and Pedestrian Programs Statewide

An update of projects and initiatives being worked on by the NDOT and the two large Metropolitan Planning Areas will be given.

13. Board Member Reports

Reports will be provided from NBPAB members on activities, initiatives or issues specific to their sectors occurring since the last meeting on July 19th, 2018.

14. Schedule and prepare items to be placed on the next agenda (For possible action)

The next NBPAB meeting is proposed to be scheduled for November 15th, 2018. Items of interest to NBPAB may be agenized for a future meeting, including items mentioned during the Board Member Reports. Action may be taken to change the next meeting date and time.

16. Adjournment (for possible action)
