**I-15/CC-215 Northern Beltway Interchange  
(Phase 4 of the I-15 North Corridor Improvements)**

**PURPOSE OF MEETING:** The Nevada Department of Transportation (NDOT), in cooperation with the City of North Las Vegas, invites you to attend a public information meeting to solicit input on the final design of the I-15/CC-215 Northern Beltway Interchange. Proposed improvements include new flyover ramps between I-15 and Clark County 215 (Las Vegas Beltway) interchange; the addition of I-15 southbound ramps and reconstruction of I-15 northbound ramps for the I-15 and Tropical Parkway interchange; reconfiguration of local streets to improve traffic flow around the interchange; and landscape and aesthetic enhancements. Design is expected to be completed in the second quarter of 2019. Construction is anticipated to begin the fourth quarter of 2019 with completion in 2022.

**PROJECT BENEFITS:** The proposed improvements will improve safety, reduce travel times, provide better access to future North Las Vegas developments, enhance operations with full freeway-to-freeway connectivity, and increase capacity along the I-15 North Corridor.
