- 1. Action to call meeting to order
- 2. Roll call of NBPAB members
- 3. PUBLIC COMMENT AND CITIZENS PARTICIPATION: No action may be taken on any matter discussed under this item that is not listed on this Agenda, although the NBPAB can direct that such items be placed on a future agenda.

At this time, any citizen in the audience may address the NBPAB on any matter. No vote can be taken on a matter not listed on the posted agenda; however, the NBPAB can direct that the matter be placed on a future agenda.

Each citizen must be recognized by the Chairperson. The citizen is then to approach the microphone to state his or her name, and to spell the last name for the record. The Chairperson may limit remarks if such remarks are disruptive to the meeting or not within the NBPAB's jurisdiction.

The Nevada Department of Transportation keeps the official record of all proceedings of the meeting. In order to maintain a complete and accurate record, copies of documents used during a presentation must be submitted to the Recording Secretary.

The Nevada Bicycle and Pedestrian Advisory Board appreciates the time citizens devote to be involved in this important process.

Public comment is limited to 5 minutes per person.

Agenda items may be taken out of the order presented on the agenda at the discretion of the chairperson. The Board may combine two or more agenda items for consideration. The Board may remove an item from the agenda or delay discussion relating to an agenda item at any time. The Board may make reasonable restrictions on time, place, and manner but will not restrict the comments based upon viewpoint.

4. Approval of the September 27th, 2018 minutes (for possible action)
Action may be taken to approve the September 27th, 2018 meeting minutes.

General Meeting Items.

Presentations are limited to 10 minutes per presenter.

5. Presentation on Don't Kill a Dream campaign from Zero Fatalities Andrew Bennet - Office of Traffic Safety

The Don't Kill a Dream Impaired Driving Campaign, is a movement intended to educate the public on the risks associated with driving under the influence, decrease the number of impaired fatalities, and positively influence safe driving behaviors, like designating a sober driver and using rideshare services. A presentation will be given.

6. Report from the 2018 Walk Bike Places Albert Jacquez, Cathy Balcon, Ron Floth, Diana Hollander

Walk Bike Places is a national conference for walking, bicycling, and placemaking held in North America bi-annually. The Summit was held September 16-19, 2018, in New Orleans. A report of any new items and issues of national interest that were presented at the summit will be given.

Discussion of legality of bicycles and scooters on sidewalks Ron Floth Nevada law does not specifically authorize nor prohibit the operation of a bicycle upon a sidewalk; however, local government entities may enact their own ordinances or municipal codes regarding a prohibition. A matrix of known ordinances and laws will be presented.
- 8. Report on Share the Road Specialty License Plates and Grant Program Albert Jacquez (for possible action)

The NBPAB developed a "Share the Road" specialty license plate to provide additional funding for local bicycle and pedestrian initiatives throughout the state. Funds are made available through a competitive grant process administered by the NDOT. An update of available plate funds, and status of the 2019 grant cycle, will be given. Action may be taken to approve the proposed call for grant applications.

9. Electric Bicycle Overview

Bicycles equipped with small electric motors have emerged as a growing industry trend over the last few years. These conveyances were recognized under Nevada law in 2009. While their share of the industry market is still small, their introduction has brought to light a number of issues, concerns, and opportunities, whether or not perceived or real, related to their place in transportation and recreation systems. An update on the state of this segment of the bicycle industry

will be given.

10. 2019 National Bicycle Summit (for possible action)

The board may take action to send two representatives to attend the 2019 National Bicycle Summit, March 9-12, 2019, in Arlington, VA. The National Bicycle Summit is an annual gathering of bicycling organizations and advocates. Action may be taken to identify two board members to attend the National Summit.

11. Legislative Update

An update will be provided about what is being proposed to the legislature pertaining to bicyclist and pedestrians during the 2019 Session.

12. Reports from the Bicycle and Pedestrian Programs Statewide

An update of projects and initiatives being worked on by the NDOT and the two large Metropolitan Planning Areas will be given.

13. Board Member Reports

Reports will be provided from NBPAB members on activities, initiatives or issues specific to their sectors occurring since the last meeting on September 27th, 2018.

14. Schedule and prepare items to be placed on the next agenda (for possible action)

The next NBPAB meeting is proposed to be scheduled for January 17th, 2019. Items of interest to NBPAB may be agenized for a future meeting, including items mentioned during the Board Member Reports. Action may be taken to change the next meeting date and time.
