(For Possible Action) Discuss NVAA and NATAC legislative proposals to support an Assembly Bill in the upcoming legislative meetings to include Tax Incentives and establishing a permanent "Fund for Aviation". Identify and Vote to select committee members to perform action issues identified by NATAC such as the renewal of the Fund for Aviation in the upcoming legislative sessions. Review forming a legislative working group or committee member assignments with a focus on attending and presenting at upcoming legislative committee sessions on the following aviation issues.
  - a. **Tax Incentive:** "Aerospace Engineer Workforce Tax Credit" program offering aerospace companies up to a \$12,500 annual tax credit for each engineer hired and employed for up to five years. The program would also offer Engineers a direct tax credit for up to \$2,000 on their own State Ad Valorem Property taxes for five years. Aerospace Companies could claim a 10 percent deduction, up to \$12,500, on an employee's salary if the engineer came from a Nevada school. The proposed NRS for Nevada could also include Flight Schools, Mechanics Schools, FBO's, Aircraft Maintenance Shops, and Aerospace Educational incentives.
  - b. **Fund for Aviation**: In conjunction with the incentives the Nevada Airport Managers Association (NVAA) request permanent budget allocation for the "Fund for Aviation" specifically for the enlargement, improvement or maintenance of any airport, landing area, or air navigation facility, or to improve air service to outlying communities. As in NRS under SB 526 that provided \$500,000 for the "Fund for Aviation", we recommend an increase to \$1 million dollars to cover 100% of the FAA AIP local matching funds we need based on the states average apportionment.

### 1. Call to order and determination of quorum for the NATAC meeting.

The meeting was called to order at 10:50 by Kurt Haukohl and it was determined that a quorum was in attendance.

### 2. Public comment

No comments

# 3. Vote to approve, amend, or edit the minutes of the previous NATAC Meeting held on November 15, 2016 (for possible action)

Kurt commented he had made one correction on the minutes. Wendy Rudder made a motion to approve the minutes, seconded by Linda Law. A vote was taken, the motion was approved and carried.

# 4. Nominate a new Vice-Chairman for the coming 2 years in accordance with the NATAC Bylaws (for possible action)

Mike Dikun and Chris Johnson were nominated for the Vice-Chairman position. A vote was taken with some members abstaining. Mike Dikun was elected Vice-Chairman with nine votes and four votes for Chris Johnson.

# 5. Vote to approve the Fund for Aviation draft amendments to the Aviation Grant Policy and Procedures Manual (AGPPM) (for possible action)

Select and vote to approve each of the following changes to the manual:

"NDOT will reimburse the matching funds up to the amount approved by the Director based on the actual amount of funds expended. Those funds not expended will be retained by NDOT."

Kurt stated there are two changes to the policy manual that became necessary and explained the reason why these changes took place.

Discuss and approve proration of grant reimbursement, and a computational limit of 20% maximum deviation from the original FAA AIP Grant award in accordance NRS 494.048 and Senate Bill (SB) 514-Sec. 50.

Kurt stated if someone does not exercise the grant it can be carried over to the subsequent year, if the FAA keeps the grant open for those that have come in under on a project still is still currently working on it.

Kay Bennett wanted to clarify that those funds not expended will be retained by NDOT Fund for Aviation, Kurt replied that is correct.

A motion was made to amend the language to assure it states, "return to the Fund for Aviation" by Linda Law, second by Mike Dikun. A vote was taken, motion passed.

Numerous questions were asked by members and discussion followed.

Kay Bennett made a motion that the NATAC approve and vote to support recommendations for future research, planning, studies, grants and other programs undertaken by NDOT Aviation Section as outlined in the agenda. Seconded by Wendy Rudder. Vote was taken, and motion passed.

7. Review, discuss, and vote to approve recommendations for the proposed Fund for Aviation matching grant program for FAA AIP Grants issued in 2017 (for possible action) When requested, the NATAC will vote to amend or approve the local matching proration scheme attached for 2017-2018 representing FAA AIP 2017 airport projects (Airport Project List) in this packet of documents

Members looked over the Airport Project List and ask the following questions:

Based on the residuals being sent back to the Fund for Aviation, if there is any excess would it be added to the \$107,500 and re-appropriated? Kurt answered it would and those funds being carried forward possibly to the next program year. Kurt stated the license plate fund is a diminishing fund and he can't pinpoint how much income is received. He has included what is available in this year's program estimate.

With regards to the grants percentage of program, how does Kurt arrive at the percentages that range from 16% to ½ % for allocating these funds? Kurt replied it is based on the size of the airport's total grant volume. This list is based on the grants the FAA awarded to the Nevada Airports for eligible trust fund for 2017. Kurt commented the 2016 grants are not all paid yet, some are just being closed out.

Chris Johnson made a motion to approve, seconded by Mike Dikun. Vote taken, motion approved.

Stacy Howard requested Kurt to ask for an extension on this item as when voting for money to be spent or distributed NVAA would have to abstain. She also asks Kurt that each time he asks about motions related to spending that he ask for an abstention, so it will be on the record.

### 8. Discussion of aviation activity in Nevada regarding:

- (a) Statewide Military Land-Use Changes and Airspace Appropriations
- (b) UAV/UAS statewide and at local airports
- (c) Nevada Airports Association Annual Meeting
- (d) Upcoming events, airshows, fly-ins, open houses, and form any workgroups needed to address airport/aviation specific news and/or issues

Chris Johnson reported the NVAA Conference will be held at the Carson Valley Inn in Minden on March 27 - 30, 2018. Looking for sponsors and speakers. The information will be on the web-page soon.

Kurt introduced Doug Miller, Transportation Analyst, from the Governor's Office. Doug and Kurt have been working on the Fallon Air Space, taking of the corridors, over Hwy 50 and 95. Kurt explained because of the changes in NEPA that occurred in 1967, if a person wants a restricted airspace they must own the land under the restricted airspace. He explained the problem with airspace over Hwy 50 & 95 and reconfiguration according to the FAA's requirement under NEPA.

Doug Miller stated that who we are negotiating with is a huge process, but the Governor is representing Nevada in that process and there are several different departments at the staff level that are negotiating with people from NEPA, such as Transportation, NDOW, Office of Energy, etc. The Governor has an alternative that will be assessed in addition to the desires of the Navy in the NEPA process. Doug commented that the Governor is very supportive of the Navy. This issue has been ongoing for quite a while and is in the process of being worked on.

Doug commented that no one understands aviation in the department except for Kurt and a few others. He explained he has received maps that are not true aviation maps and some descriptions of some of military off limits flying areas do not match with the aviation maps and are in the process of trying to straighten out the situation with the assistance of the FAA, Kurt and the Aviation Division.

Question: what is the State's position with regards of what is going on with the restricted airspace and the corridors? Doug replied that changes by the day and he is not authorized to make a statement. Doug stated the Governor supports the military's desires and needs, but wants to make sure that all Nevadans are also represented, and the use of Nevada is preserved. He stated the need to have connectivity throughout the state for travel for all aviation purposes and that must be preserved.

Kay Bennett stated the plan in its current restricted configuration will infringe on the Silver Springs Airports' newly established instrumental approach. Doug commented through NEPA there are several different alternatives EIS has not submitted yet. The

base must reach out to the communities and there is still much work to do. Talking and gathering concerns in the Nevada communities. At this time, he wouldn't attempt to comment on a specific alternative as they are not final and keep changing. Doug stated the Aviation Division is a good place to get information on the aviation side, the counties have NACO and all the different departments of the state level are engaged in the situation.

Kurt stated FAA and NEPA is working in the aviation's favor and the people in Seattle who make the decision of the individual blocks of airspace locations are required to follow NEPA.

**9.** Discuss NATAC's legislative objectives and issues for the upcoming fiscal years both in Federal and State law (for possible action) Develop working group or committee member assignments with a focus on upcoming legislative and aviation funding issues. Vote to select committee members to perform action issues identified by NATAC.

Kurt volunteered to be the NDOT liaison for aviation. Kay Bennett introduced her new partners, Joel and Marco Lucich. She stated she hopes NAMA has a legislative committee to become active now on requests for on-going funding and to establish some reasonable goals for the next session.

Mike Dikun ask numerous questions concerning processes, procedures and strategies of funding for aviation and how to get the legislators to support aviation's funding. Discussion, comments suggestion and questions were made by many of the members.

Doug Miller stated when the Governor was elected the state was in a recession. The Governor's Office is working on plans for the new Nevada which will bring a lot of diverse industries to the state and aviation is a large part of that. He suggested that NATAC should have a government affairs committee to represent the organization.

Kurt stated the state receives approximately \$49 million a year in total entitlements in the entire program. He stated the rural airports need a million dollars to meet all the location match. Kurt stated all the fuel tax revenue must go back to the airport that it was collected according to the FAA to meet compliance.

Kurt suggested the conversation be carried forward to the NVAA meeting and possibly consider a more formal group of members to work on the legislative aviation funding.

**10.** Discuss NVAA License Plate Program funding to the Nevada Airport Aviation Trust Fund (for possible action) Review audit request for information and statements of income from Nevada DMV. Discuss the limited ability to follow income to the fund from the program.

Kurt commented the past NVAA chairman was sent an audit request from the State Auditor on the income from the license plate program. He reported to the members the process he went through with DMV. Bill Story suggested NATAC needs an agreement with DMV.

**11.** Discuss NATAC or NVAA Website Update and continued operation (for possible action) Discuss website objective, form a working group or committee to establish and individual or organization to set-up and maintain a website.
