SUBJECT: Request to Match FAA AIP Grants from the Fund for Aviation


The Nevada Aviation Technical Advisory Committee (NATAC) met on December 6<sup>th</sup>, 2018 in Carson City. The Nevada Department of Transportation (NDOT) Aviation Program presented a list of Federal Aviation Administration (FAA) grants awarded through the FAA Airport Improvement Program (AIP) for the Federal Fiscal 2018 year. The list contains eligible airports and projects awarded in Nevada to General Aviation Airports and the NATAC reviewed and voted to recommend the attached list to NDOT. The 2018 FAA AIP Grants eligible for Airport Projects under NRS 494.048 are those grants NDOT intends to provide a partial reimbursement for local matching funds in accordance with the attached program schedule.
