## NDOT TO ADDRESS AESTHETICS ISSUES OF US 95/US 6/US 50

FALLON, NEVADA – The Nevada Department of Transportation (NDOT) will hold an open house on November 16, 2005 from 4 to 7 p.m. in the Oasis Room of the Fallon Convention Center, 100 Campus Way, Fallon.

Your attendance is important to making the most of Nevada's highways. Governor Kenny Guinn has stated, "Highways are among the most visible artifacts of our civilization. They welcome our guests upon arrival and send them on their way when they leave. Because they affect our ecosystems and the way our neighborhoods and places of business connect to each other, they influence the quality of life of every citizen in the state." This is an opportunity for community members to suggest opportunities and ideas regarding the landscape and aesthetics of their highways.

Issues to be addressed include improving the relationship between highways and communities, increasing tourism opportunities, and enhancing the attractiveness of the corridor through communities. Working together, NDOT and local communities can identify opportunities for partnerships and improvements that will result in improved highway corridors that enhance the quality of life of Nevada's citizens as well as tourism and travel within the state.

Throughout the year, NDOT and a consulting team have been working on a plan to address landscape and aesthetics in highway design. A Technical Review Committee comprised of members of local public agencies and organizations is adding valuable local

insight and ideas to the plan. This segment of the plan focuses on US 95 from the Clark County line west of Indian Springs north to I-80 at Fernley, US 6 from the California state line east to Warm Springs, US 50 from Six Mile Canyon Road near Dayton east to New Pass Summit, Alt 95 through Yerington, and Alt 50. During the planning process, the team has assessed the existing conditions along these highways and developed preliminary ideas for improving the appearance of the NDOT right-of-way.

This open house is the first of two public workshops that are planned. With public and stakeholder input, a final Landscape and Aesthetics Corridor Plan will be prepared. NDOT will use this document as a management tool for establishing the type and level of landscape improvements when new roadway projects are built. Community members are encouraged to suggest new opportunities and ideas with the goal of creating a more beautiful highway system.
