- 3. PUBLIC COMMENT AND CITIZENS PARTICIPATION: No action may be taken on any matter discussed under this item that is not listed on this Agenda, although the NBPAB can direct that such items be placed on a future agenda.

The Nevada Department of Transportation keeps the official record of all proceedings of the meeting. In order to maintain a complete and accurate record, copies of documents used during a presentation must be submitted to the Recording Secretary.

The Nevada Bicycle and Pedestrian Advisory Board appreciates the time citizens devote to be involved in this important process.

Public comment is limited to 5 minutes per person.

Agenda items may be taken out of the order presented on the agenda at the discretion of the chairperson. The Board may combine two or more agenda items for consideration. The Board may remove an item from the agenda or delay discussion relating to an agenda item at any time. The Board may make reasonable restrictions on time, place, and manner but will not restrict the comments based upon viewpoint.

5. Presentation of Vision Zero Truckee Meadow Action Plan Rebecca Kapuler (for possible action)

Vision Zero Truckee Meadows task force has created an action plan to bring the number of traffic fatalities to zero in Washoe County by the year 2030. RTC Washoe will apply with the Vision Zero Network to become a Vision zero community. The Vision Zero Task Force Truckee Meadows Action Plan will be presented. Action may be taken to provide a letter of support to Washoe RTC to include with the application.

6. Proposed changes to education related to recently passed legislation on electric foot scooters Albert Jacquez

A discussion will take place to help identify more effective methods of safety education related to recently passed legislation on electric foot scooters.

7. Review of Statewide Bicycle Touring Map Update Janie Fromm The NDOT develops and publishes a Nevada Bicycle Map. These maps are available free of charge to the public. A presentation of the current map will be given, proposed revision will be discussed.

8. Attendance at 2019 APBP Professional Development Seminar in Portland, Oregon (for possible action)

The 2019 APBP Professional Development Seminar is a biennial conference distinguished by longer, in-depth sessions and a collaborative atmosphere that will supply the tools to move active transportation. The Seminar takes place August 25-29, 2019 in Portland, Oregon. Action may be taken to send two representatives to attend.

9. Trails, Transportation and Tourism Summit

The Trails Transportation and Tourism Summit (formerly the Nevada Bicycle and Pedestrian Summit) is an annual meeting focused on issues affecting bicyclists and pedestrians. The Summit is scheduled for November 5th-7th, 2019 at Mont Bleu Lake Tahoe. A summary of summit coordination and agenda will be discussed.

10. Overview of the Nevada Bicycle and Pedestrian Award Program Bill Story (for possible action)

The State Bicycle and Pedestrian Award program recognizes exemplary people, agencies, and organizations that are making a significant difference in bicycling and pedestrian programs, facilities, safety, or promotion in Nevada. These are awarded by the Board at the annual Bicycle and Pedestrian Summit. Action may

be taken to choose award recipients.

11. Discussion and update of emerging technologies related to micro-Mobility Scott Bohemier NDOT NV2X

Nevada is seeing an increase in new personal traveling conveyances A discussion and update will take place on issues, concerns, and opportunities.

An update of projects and initiatives being worked on by the NDOT and the two large Metropolitan Planning Areas will be given.
