PUBLIC INFORMATION MEETING TO SOLICIT COMMENTS FOR THE NEVADA DEPARTMENT OF TRANSPORTATION REVISED STORMWATER MANAGEMENT PROGRAM PLAN

PURPOSE OF MEETING: The Nevada Department of Transportation (NDOT) was reissued a National Pollutant Discharge Elimination System Municipal Separate Storm Sewer Systems (MS4) Permit NV0023329 (Permit), from the Nevada Division of Environmental Protection on August 10, 2018. The Permit authorizes stormwater (and specific non-stormwater) discharges from the NDOT right-of-way into waters of the United States. A requirement of the Permit is the development and implementation of a Stormwater Management Program, which is described in NDOT's Stormwater Management Program Plan. The Plan details NDOT's programmatic approach with meeting Permit requirements to reduce the discharge of pollutants from NDOT's MS4 to the maximum extent practicable. NDOT is seeking your input on the Plan.
