- 2. Roll call of NBPAB members**
- 3. PUBLIC COMMENT AND CITIZENS PARTICIPATION:** No action may be taken on any matter discussed under this item that is not listed on this Agenda, although the NBPAB can direct that such items be placed on a future agenda.

At this time, any citizen in the audience may address the NBPAB on any matter. No vote can be taken on a matter not listed on the posted agenda; however, the NBPAB can direct that the matter be placed on a future agenda.

Each citizen must be recognized by the Chairperson. The citizen is then to approach the microphone to state his or her name, and to spell the last name for the record. The Chairperson may limit remarks if such remarks are disruptive to the meeting or not within the NBPAB's jurisdiction.

The Nevada Department of Transportation keeps the official record of all proceedings of the meeting. In order to maintain a complete and accurate record, copies of documents used during a presentation must be submitted to the Recording Secretary.

The Nevada Bicycle and Pedestrian Advisory Board appreciates the time citizens devote to be involved in this important process.

Public comment is limited to 5 minutes per person.

Agenda items may be taken out of the order presented on the agenda at the discretion of the chairperson. The Board may combine two or more agenda items for consideration. The Board may remove an item from the agenda or delay discussion relating to an agenda item at any time. The Board may make reasonable restrictions on time, place, and manner but will not restrict the comments based upon viewpoint.

- 4. Approval of the September 19th, 2019 minutes (for possible action)**
Action may be taken to approve the September 19th, 2019 meeting minutes.

Presentations are limited to 10 minutes per presenter.

- 5. Review and discuss the Board's Goals, Objectives and Mission Statement**

A representative from the NDOT will provide an overview of the documents to members of the Board. In addition, a discussion about commissioning a facilitator in a future meeting to guide a discussion regarding revisions to the reviewed Goals, Objectives and Mission Statement.

- 6. Annual election of the Nevada Bicycle and Pedestrian Advisory Board Officers for Chairperson and Vice Chairperson (for possible action)**

The Nevada Bicycle and Pedestrian Advisory Board elections are held each January. Action may be taken to elect a chairman and vice chairman for the 2020 calendar year.

- 7. Colin Robertson with Nevada Division of Outdoor Recreation**

The Nevada Department of Conservation and Natural Resources has appointed Colin Robertson as the new Administrator for Nevada Division of Outdoor Recreation. An overview of the new program will be presented.

- 8. Update on change in the scope for "Share the Road" grant agreement for Carson City Schools Foundation (for possible action) *Albert Jacquez***

Carson Schools Foundation non-profit organization that supports students, teachers and families of the Carson City School District. In March 2019 they were granted \$2000 to hold Carson City Bicycle Family Fun and Safety Day on May 2nd. The Carson City Schools Foundation has opted out of the agreement.

- 9. Nevada Department of Transportation Active Transportation Plan**

The Nevada Department of Transportation will be developing an Active Transportation Plan, this is a plan for a transportation system that provides multiple alternatives for travel. The Active Transportation Plan will focus on walking and cycling, including connectivity between other modes such as transit. A discussion on what the plan should include will take place.

10. **Trails, Transportation and Tourism Summit** *Scott Bohemier*
The Trails Transportation and Tourism Summit is an annual meeting focused on issues affecting bicyclists and pedestrians. A report on the 2019 Summit will be given along with an update on the planning of the 2020 summit.

11. **Reports from the Bicycle and Pedestrian Programs Statewide**
An update of projects and initiatives being worked on by the NDOT and the two large Metropolitan Planning Areas will be given.

12. **Board Member Reports**
Reports will be provided from NBPAB members on activities, initiatives or issues specific to their sectors occurring since the last meeting on September 19th, 2019.

13. **Schedule and prepare items to be placed on the next agenda (for possible action)**
The next NBPAB meeting is proposed to be scheduled for July 16th, 2020. Items of interest to NBPAB may be agenized for a future meeting, including items mentioned during the Board Member Reports. Action may be taken to change the next meeting date and time.
