Subject: Agenda Item #4 Statewide Transit Plan Update Discussion and Interaction

#### **Background:**

The Nevada Department of Transportation (NDOT) is seeking to develop a statewide transit plan to better establish, document and communicate the overarching goals and objectives of its transit program, transit provider needs and the communities it serves. The federally required State Long-Range Transportation Plan (One Nevada Plan) is the umbrella document covering the movement of people and freight across all modes; focused modal and topic plans help to refine broad policies into more specific strategies. Nevada's statewide transit plan could cover multiple subtopics from a wide array of potential study areas, many of which were presented to the TPAC at the July 29, 2020 meeting. The TPAC has since provided input via SurveyMonkey to help refine the universe of potential subtopics. NDOT staff has drafted a scope of work (SOW) based on this input.

Based on TPAC input and other research conducted by NDOT Transit staff, the statewide transit plan will draw from relevant sections of existing documents, such as NDOT's 2018 Coordinated Human Services Transportation Plan and Regional Transportation Plans, to better align local goals and objectives with the statewide approach. It will also analyze financial resources and needs over a 20-year period and explore new ways to fund, streamline and enhance the transit system, among other subtopics.

The next phase of this process will be to finalize the SOW and issue an RFP used to select a consultant during FFY 2021. Presentation of this item will include a recap of survey results and an overview of the subtopics selected for inclusion in the draft SOW. Additional feedback from the committee is needed to finalize the SOW in advance of the release of an RFP.

#### Action:

Staff would like to request input from the TPAC. This will assist staff in finalizing the scope for inclusion in an RFP. Input from TPAC members will be accepted via email until November 13<sup>th</sup> (please send comments to Graham Dollarhide at <a href="mailto:gdollarhide@dot.nv.gov">gdollarhide@dot.nv.gov</a>). Staff anticipates presentation of an update on the statewide transit plan to the TPAC at the April 2021 meeting for additional comment and possible opportunity to participate in the plan's public participation process.

Subject: Agenda Item #6 Update on Nevada Rail Plan Update

The NDOT is updating the state rail plan which was previously completed in 2012 staff will provide an update and discuss the plan and its purpose.

### **Background:**

The Federal Railroad Administration (FRA) issued final state rail plan guidance on September 17, 2013. Section 303 of the Passenger Rail Investment and Improvement Act of 2008 (PRIIA) requires states to develop FRA-accepted state rail plans and encourages state involvement in rail policy, planning, and development. The guidance explains the process to be followed in developing state rail plans, including minimum content requirements, a standardized format, and FRA's review and acceptance process.

Section 11315 of the Fixing America's Surface Transportation Act of 2015 (FAST Act) made subsequent changes to state rail plan requirements, including specifying that a state-approved rail plan be submitted every four years for acceptance by FRA, rather than the five years allowed under PRIIA. Because individual state rail plans must be updated at least every four years, and because state update cycles vary, there is no set schedule for when states will submit rail plans to FRA for review and acceptance.

According to the FRA this plan is required to help Nevada address a broad spectrum of issues, including an inventory of the existing passenger and freight rail transportation system and rail services/facilities within the state. Plans should also include an explanation of the state's passenger and freight rail service goals and objectives within the context of the state's overall transportation system; an analysis of the public benefits of freight and passenger rail to the state; and a long-range investment program for current and future freight and passenger rail infrastructure in the state. It is important that Nevada has a Federally compliant rail plan, the primary reason is to allow the state to have the option of applying for Federal capital grants under Sections 301, 302 and 501 of the PRIIA.
