- 1. Action to call meeting to order
- 2. Roll call of NBPAB members
- 3. PUBLIC COMMENT AND CITIZENS PARTICIPATION:

No action may be taken on any matter discussed under this item that is not listed on this Agenda, although the NBPAB can direct that such items be placed on a future agenda.

At this time, any citizen in the audience may address the NBPAB on any matter. No vote can be taken on a matter not listed on the posted agenda; however, the NBPAB can direct that the matter be placed on a future agenda.

Each citizen must be recognized by the Chairperson. The citizen is then to approach the microphone to state his or her name, and to spell the last name for the record. The Chairperson may limit remarks if such remarks are disruptive to the meeting or not within the NBPAB's jurisdiction.

The Nevada Department of Transportation keeps the official record of all proceedings of the meeting. In order to maintain a complete and accurate record, copies of documents used during a presentation must be submitted to the Recording Secretary.

The Nevada Bicycle and Pedestrian Advisory Board appreciates the time citizens devote to be involved in this important process.

Public comment is limited to 5 minutes per person.

Agenda items may be taken out of the order presented on the agenda at the discretion of the chairperson. The Board may combine two or more agenda items for consideration. The Board may remove an item from the agenda or delay discussion relating to an agenda item at any time. The Board may make reasonable restrictions on time, place, and manner but will not restrict the comments based upon viewpoint.

- 4. Approval of the September 17th, 2020 minutes (for possible action)
  Action may be taken to approve the September 17th, 2020 meeting minutes.
- 5. Annual election of the Nevada Bicycle and Pedestrian Advisory Board Officers for Chairperson and Vice Chairperson (for possible action)

  The Nevada Bicycle and Pedestrian Advisory Board elections are each January. Action may be taken to elect a Chair and Vice Chair for the 2021 calendar year.
- 6. Update for the "Share the Road" License Plates and Grants Albert Jacquez
  The NBPAB developed a "Share the Road" specialty license plate to provide
  additional funding for local bicycle and pedestrian initiatives throughout the state.
  An update on previously awarded grants, budget balance and future call for
  projects will be given.
- 7. USBR Presentation Kerry Irons Adventure Cycling Association
  The United States Bicycle Route System (abbreviated USBRS) is the national cycling route network of the United States. It consists of interstate long-distance cycling routes that use multiple types of bicycling infrastructure, including off-road paths, bicycle lanes, and low-traffic roads. A presentation will be given about the USBR system and Nevada's routes.
- 8. No More Ghost Bikes Campaign Scott Bohemier

  The campaign was originally slated for spring/summer but was moved up in response to the recent tragedy in Las Vegas. The presentation will show how NDOT will be working with other entities both private and public. The campaigns label, "No More Ghost Bikes", will be used as a conversation starter to work towards safer roads for all users throughout Nevada.

## 9. Attendance at National Bicycle Summit in Washington D.C. (for possible action) Scott Bohemier

The National Bicycle Summit is an annual gathering of bicycling organizations where stakeholders interested in bicycling issues attend educational sessions. The 2021 National Bike Summit will take place **online**, February 28 - March 3, 2021. Action may be taken to select up to two members of the NBPAB to attend the National Summit

#### 10. Reports from the Bicycle and Pedestrian Programs Statewide

An update of projects and initiatives being worked on by the NDOT and the Washoe County and Clark County Metropolitan Planning Areas will be given.
