No action may be taken on any matter discussed under this item that is not listed on this Agenda, although the NBPAB can direct that such items be placed on a future agenda.

At this time, any citizen in the audience may address the NBPAB on any matter. No vote can be taken on a matter not listed on the posted agenda; however, the NBPAB can direct that the matter be placed on a future agenda.

Each citizen must be recognized by the Chairperson. The citizen is then to approach the microphone to state his or her name, and to spell the last name for the record. The Chairperson may limit remarks if such remarks are disruptive to the meeting or not within the NBPAB's jurisdiction.

The Nevada Department of Transportation keeps the official record of all proceedings of the meeting. To maintain a complete and accurate record, copies of documents used during a presentation must be submitted to the Recording Secretary.

The Nevada Bicycle and Pedestrian Advisory Board appreciates the time citizens devote to be involved in this important process.

Public comment is limited to 5 minutes per person.

Agenda items may be taken out of the order presented on the agenda at the discretion of the chairperson. The Board may combine two or more agenda items for consideration. The Board may remove an item from the agenda or delay discussion relating to an agenda item at any time. The Board may make reasonable restrictions on time, place, and manner but will not restrict the comments based upon viewpoint.

4. Approval of the March 18th, and March 29th 2020 minutes (for possible action)

Action may be taken to approve the March 18th, and March 29th 2020 meeting minutes.

5. Washoe RTC Presentation on retiming lights for pedestrians *RTC representative*

Washoe RTC recently retimed many of their traffic lights to better accommodate pedestrians. A presentation of this process will be given.

6. Update on Trails, Transportation and Tourism Summit *Scott Bohemier*

The Trails Transportation and Tourism Summit is an annual meeting focused on issues affecting bicyclists and pedestrians. an update on the planning of the next summit will be given

7. Update for the “Share the Road” License Plates and Grants *Albert Jacquez*

The NBPAB developed a “Share the Road” specialty license plate to provide additional funding for local bicycle and pedestrian initiatives throughout the state. An update on previously awarded grants, budget balance and future call for projects will be given.

8. 81st Legislative Session Update, Alan Bohemier,
NDOT Active Transportation Manager **(for possible action)**

An update will be provided on the introduction of any proposed legislation related to bicycling or walking. Action may be taken to provide advisement to appropriate agencies regarding these proposed changes to State law.

9. Reports from the Bicycle and Pedestrian Programs Statewide

An update of projects and initiatives being worked on by the NDOT and the Washoe County and Clark County Metropolitan Planning Areas will be given.

10. Board Member Reports

Reports will be provided from NBPAB members on activities, initiatives, or issues specific to their sectors occurring since the last meeting on March 18th, 2021.

11. Schedule and prepare items to be placed on the next agenda (for possible action)

The next NBPAB meeting is proposed to be scheduled for July 15th, 2021. Items of interest to NBPAB may be agenized for a future meeting, including items mentioned during the Board Member Reports. Action may be taken to change the next meeting date and time.
