Subject: Agenda Item #2 Electric Vehicle (EV) Charging Roundtable Discussion

Background:

The purpose of this agenda item is to provide background, introduction, current state, and future plans of the electric vehicle (EV) network in Nevada. Multiple agencies will be a part of this discussion. This discussion could continue at future TPAC meetings.

Today's discussion will focus on:

Subject: Agenda Item #3 Update on the State Planning & Research (SPR) Corridor Planning

Background:

The purpose of this agenda item is to provide an update on NDOT's SPR-Corridor Planning progress.

This presentation will:

Review corridor studies that are currently underway. These include: SR 431 Mt. Rose, SR 659 McCarran Loop, and US 50 (Lake Tahoe, Spooner Jct. to Stateline); and

Request the TPAC to provide input on the corridor studies under future consideration. These include SR 159 and SR 160 Blue Diamond Road – requesting input regarding scope of studies and respective termini; and

There will be a discussion of how the new SPR Corridor Planning task will help to feed and inform future transportation needs. We will also talk about limitations on the SPR Program due to staffing, budget, etc. Staff is planning to update the TPAC on a quarterly basis on the status of the NDOT Corridor Plans.

Subject: Agenda Item #4 Introduction and opportunity to evaluate and provide input into the Federal Grant Support Checklist

Staff will ask the TPAC to evaluate and provide input to the discretionary grant support checklist; NDOT has formalized the process for requesting department support related to discretionary grants.
