The Nevada Department of Transportation keeps the official record of all proceedings of the meeting. To maintain a complete and accurate record, copies of documents used during a presentation must be submitted to the Recording Secretary.

The Nevada Bicycle and Pedestrian Advisory Board appreciates the time citizens devote to be involved in this important process.

Public comment is limited to 5 minutes per person.

Agenda items may be taken out of the order presented on the agenda at the discretion of the chairperson. The Board may combine two or more agenda items for consideration. The Board may remove an item from the agenda or delay discussion relating to an agenda item at any time. The Board may make reasonable restrictions on time, place, and manner but will not restrict the comments based upon viewpoint.

4. Approval of the July 21st, 2021 minutes (for possible action)

Action may be taken to approve the July 21st, 2021 meeting minutes.

5. Presentation of the “I Can Bike Program” *Diana Rovetti*

"iCan Bike" is a bike camp for kids and adults with developmental disabilities, using specialized equipment and trained volunteers.

Since 2007 the I Can Bike Program has successfully taught approximately 20,000 people with disabilities to ride a conventional two-wheel bicycle. The impact of learning to ride a bicycle independently.

6. Presentation of Ped Safety Zone *City of Reno representative*

A pedestrian safety zone is designed to reduce driving speeds and raise driver awareness in areas where people are at a higher risk of being struck and killed in collisions with motor vehicles. The City of Reno established Nevada's first pedestrian safety zone. A presentation will be given

7. Update for the “Share the Road” License Plates and Grants *Albert Jacquez*

The NBPAB developed a “Share the Road” specialty license plate to provide additional funding for local bicycle and pedestrian initiatives throughout the state. An update on previously awarded grants, budget balance will be given.

8. Reports from the Bicycle and Pedestrian Programs Statewide

An update of projects and initiatives being worked on by the NDOT and the Washoe County and Clark County Metropolitan Planning Areas will be given.

Reports will be provided from NBPAB members on activities, initiatives, or issues specific to their sectors occurring since the last meeting on July 21st, 2021.
