The Nevada Bicycle and Pedestrian Advisory Board appreciates the time citizens devote to be involved in this important process.

Public comment is limited to 5 minutes per person.

The Board may remove an item from the agenda or delay discussion relating to an agenda item at any time. The Board may make reasonable restrictions on time, place, and manner but will not restrict the comments based upon viewpoint.*

**5. Annual election of the Nevada Bicycle and Pedestrian Advisory Board Officers for Chairperson and Vice Chairperson (for possible action)**
