No action may be taken on any matter discussed under this item that is not listed on this agenda, although the NBPAB can direct that such items be placed on a future agenda.

At this time, any citizen in the audience may address the NBPAB on any matter. No vote can be taken on a matter not listed on the posted agenda, however, the NBPAB can direct that the matter be placed on a future agenda.

Each citizen must be recognized by the Chairperson. The citizen is then to approach the microphone to state his or her name, and to spell the last name for the record. The Chairperson may limit remarks if such remarks are disruptive to the meeting or not within the NBPAB's jurisdiction.

The Nevada Department of Transportation keeps the official record of all proceedings of the meeting. To maintain a complete and accurate record, copies of documents used during a presentation must be submitted to the Recording Secretary.

The Nevada Bicycle and Pedestrian Advisory Board appreciates the time citizens devote to being involved in this important process.

Public Comment is limited to 5 minutes per person.

*Agenda items may be taken out of the order presented on the agenda at the discretion of the chairperson. The Board may combine two or more agenda items for consideration. The Board may remove an item from the agenda or delay discussion relating to an agenda item at any time. The Board may make reasonable restrictions on time, place, and manner but will not restrict the comments based upon viewpoint.*

4. **Approval of the March 31<sup>st</sup> meeting minutes** *(for possible action)*

Action may be taken to approve the March meeting minutes.

5. **Discussion of roles and responsibilities of the Nevada Bicycle and Pedestrian Advisory Board** *(for discussion)*

This item discusses the Nevada Bicycle and Pedestrian Advisory Board's roles as they are outlined in the bylaws of the board.

The Nevada Bicycle and Pedestrian Advisory Board (NBPAB) was created by the State Legislature to:

- Promote programs and facilities for the safe use of bicycles and pedestrian safety in this state
- Advise appropriate agencies of the State on policies, programs and facilities for the safe use of bicycles and pedestrian safety

It consists of [14 members](#) appointed by the Governor. Seven members represent pre-determined segments of Nevada's bicycle and pedestrian stakeholders. The remaining seven members represent State agencies whose overview relates to bicycling and walking. The NBPAB is not part of the Department of Transportation as it is advisory to all state agencies. The Department of Transportation provides secretarial and coordination functions for the Board.

One of the purposes of NBPAB is to be a voice for citizens to our state agencies and local municipalities to provide valuable input into the decision and planning process, which could include consideration of bicycle and pedestrian facilities, policies, and behaviors.

6. **Possible creation of a letter of support for issues brought forth by the bicycle advocacy group Muscle Powered** *(for possible action)*

In March, the bicycle advocacy group Muscle Powered brought forth concerns that the shared use path along Highway 395 as it intersects/crosses the Old Lincoln Highway is an area of concern. They seek a letter of support for possible action to address these concerns.

**7. Update on the Nevada Trails, Transportation, and Tourism Summit planning and future planning meetings** *(for possible discussion)*

The Nevada Department of Transportation and the Eastern Sierra Trails Coalition is set to host a “Trails, Transportation, and Tourism Summit” this fall. The NDOT will provide insight and meeting dates that board members may attend.

**8. Reports from the Bicycle and Pedestrian Programs statewide**

An update of projects and initiatives being worked on by the NDOT, Washoe County, and Clark County Metropolitan Planning Areas will be given.

**9. Board member reports**

Reports will be provided from NBPAB members on activities, initiatives, or issues specific to their sectors occurring since the last meeting on March 31<sup>st</sup>, 2022.

**10. Schedule and prepare items to be placed on the next agenda** *(for possible action)*

The next NBPAB meeting is proposed to be scheduled for July 21<sup>st</sup>, 2022. Items of interest to NBPAB may be placed on the agenda for a future meeting, including items mentioned during Board Member reports. Action may be taken to change the next meeting date and time.
