#### **Background:**

NDOT first launched our travel information system in 2007. Just over the past decade, there have been more than 41 million visits to our existing highway conditions information system. Drivers will still find up-to-the-minute highway conditions, alerts, traffic cameras and more at the same NVRoads.com web address, by dialing 511 or downloading the Nevada 511 app. We routinely remind drivers to know before they go. That means being updated on highway conditions, road construction and incidents BEFORE driving. Our goal with this update is to make it even easier to do that with our revamped 511 Nevada Travel Information system.

Additional information for agenda item #3 Nevada Freight Plan Update

#### **Background:**

The Nevada Department of Transportation (NDOT) is conducting an update of the Nevada Freight Plan. This plan is necessary to allow NDOT to utilize National Highway Freight Program (NHFP) funding to improve the state's freight network.

The Interim Freight Plan has been approved by the FHWA. The next steps include analyzing Truck GPS data, updating the Freight Program Manual, improving internal NDOT processes, and ultimately publishing the Final Freight Plan, which is scheduled to be published in the first quarter of 2023.
