SUBJECT: Federal Grant Matching from the **Fund for Aviation**

The Nevada Aviation Technical Advisory Committee (NATAC) met on July 20<sup>th</sup>, 2023, in Carson City. The Nevada Department of Transportation (NDOT) Aviation Section presented a list of Federal Aviation Administration (FAA) grants awarded for the Federal Fiscal Years 2022-2023. The list contains eligible airport projects awarded in Nevada to Rural General Aviation Airports. 
