No action may be taken on any matter discussed under this item that is not listed on this agenda, although the NBPAB can direct that such items be placed on a future agenda. Public comment is limited to 5 minutes per person.

At this time, any citizen in the audience may address the NBPAB on any matter. No vote can be taken on a matter not listed on the posted agenda, however, the NBPAB can direct that the matter be placed on a future agenda.

Each citizen must be recognized by the Chairperson. The citizen is then to approach the microphone to state his or her name, and to spell the last name for the record. The Chairperson may limit remarks if such remarks are disruptive to the meeting or not within the NBPAB's jurisdiction.

The Nevada Department of Transportation keeps the official record of all proceedings of the meeting. To maintain a complete and accurate record, copies of documents used during a presentation must be submitted to the Recording Secretary.

The Nevada Bicycle and Pedestrian Advisory Board appreciates the time citizens devote to be involved in this important process.

Agenda items may be taken out of the order presented on the agenda at the discretion of the chairperson. The Board may combine two or more agenda items for consideration. The Board may remove an item from the agenda or delay discussion relating to an agenda item at any time. The Board may make reasonable restrictions on time, place, and manner but will not restrict the comments based upon viewpoint.

4. **Nevada Bicycle and Pedestrian Advisory Board approval of meeting minutes** *(for possible action)* – *Glahnnia Rates*

Action to be taken for the approval of the May 18, 2023 meeting minutes.

5. **Review of bicycle restrictions on interstates/freeways in Nevada** *(for possible action)* – *Erin Breen/Rebecca Kapuler*

Nevada Bicycle and Pedestrian Advisory Board approval of recommending updates to current restrictions for cyclists and pedestrians on controlled access highways (freeways) (for possible action) – Albert Jacquez Action to be taken for the approval of the creation of a letter of support, to be formulated by the board, and sent to the Nevada Department of Transportation’s Director. The possible action to be taken is as follows:

- Kyle Canyon Rd – There is currently a “bicycles and pedestrians prohibited” sign at the on-ramp to I-95 northbound prohibiting cyclists and pedestrians from route. As there is no reasonable route northbound leaving Las Vegas, the removal of this sign would allow cyclists and pedestrians to travel north.
- Lamb Blvd – The current prohibited area for cyclists and pedestrians allows cyclists and pedestrians access at the north bound on-ramp at Lamb Blvd. Due to highway/freeway improvements, this area has been identified as hazardous for cyclists and pedestrians. The Nevada Department of Transportation’s active transportation team recommends access be moved to North Las Vegas Blvd and re-entry point at Exit 58 to re-enter I-15 as there is no reasonable route north-east bound out of Las Vegas after Exit 58.

An update of projects and initiatives being worked on by the NDOT, Washoe County, and Clark County Metropolitan Planning Areas will be given.
