SUBJECT: Request to match FAA AIP Grants from Fund for Aviation

The Nevada Aviation Technical Advisory Committee (NATAC) met on November 10, 2015. NDOT Aviation Section presented a list of Federal Aviation Administration (FAA) grants awarded through the Airport Improvement Program (AIP) to Nevada General Aviation Airports in Federal Fiscal Year 2015 for review and NATAC voted to recommend advisory endorsement of the following list. A Fund for Aviation matching grant program was also voted on and recommended advisory endorsement of a new *Nevada Fund for Aviation Grant Program Policy and Procedures Manual* used to administer the state matching grant program. The 2015 FAA AIP grants eligible under NRS 494.048 and Senate Bill (SB) 514 - 2015 Sec. 50 are those grants NDOT intends to match as follows:
