STTAC MEETING -

Item 1: Call to Order and Determination of Quorum*

Chairman Wes Henderson called the STTAC meeting to order at 10:07 a.m. Tim Mueller requested introductions in the north and south. It was determined that a quorum was present.

Item 2: Public Comment

Scott Hall of the Nevada Bicycle Coalition commented that he has been monitoring the TAP process and commended the NDOT Multimodal Section in making sure the rural areas are taken care of and considered in the list of projects. The projects have an impact and economic benefits and make a big difference in healthcare per person per year.

Tim Mueller announced that Leah Sirmin of FHWA will be moving to Massachusetts to work in the FHWA state office there and wished her well in her new position. Tim also introduced Emily Nunez with the State Energy Office and welcomed her to the meeting, announced that June Loreman with the BLM

will be attending the next meeting in February and Rush Wickes of the RTC of Southern Nevada is attending his first meeting today in the Las Vegas location.

Item 3: Approval of the September 16, 2013 STTAC Meeting Minutes*

Steve Bunnell made a motion to approve the September 16, 2013 STTAC meeting minutes. Clara Lawson seconded the motion. A vote was taken and the motion carried unanimously.

Item 4: NDOT Planning

Item 4a: Discussion on Amendments, Adjustments to the FY 2014-2017 Statewide Transportation Improvement Program (STIP) document and the development of the FY 2014-2023 Transportation System Projects document (Jason Van Havel)

Jason Van Havel, Assistant Chief of NDOT Program Development requested postponing this agenda item until later in the meeting.

Item 4b: Update of the NDOT Statewide Transportation Alternatives Program (Tim Mueller)

Tim Mueller of NDOT Transportation Multimodal provided an update on the Transportation Alternatives Program (TAP). Tim stated that there has been consistent interaction between the TAP applicants and the LPA group and/or Design staff. Tim commented that he is working to update the Transportation Alternatives Guidance Manual and hopes to have it distributed to the STTAC by December 20. The tentative schedule is to have the Call for Projects on the statewide projects from January 15 to February 14, 2014. There will be a short period of internal review, an applicant follow-up if needed, the Scoring Committee will review and meet March 21 to April 21, scoring results due around May 5, meet with public groups and/or entities, and the STTAC and NDOT approval in July 2014. He has met with 13 counties so far to discuss the Alternatives Program, other NDOT Planning functions, the Bridge Program, Betterment Program, and some district improvements; with meetings scheduled for Lyon and Mineral, Churchill, Lander and Pershing Counties on December 4 and Clark County on December 17, with funding of \$4.8M total for the state. The update concluded. Discussion followed.

Item 4c: Update on Road Relinquishment (AB-18) Document (Bob Madewell)

This item will be moved down in the agenda.

Item 4d: Update of I-11 & Intermountain West Corridor Study (Sondra Rosenberg)

Sondra Rosenberg of NDOT Federal Programs provided a PowerPoint presentation and background on the I-11 and Intermountain West Corridor Study. Sondra discussed background, such as high priority corridor and interstate designation as well as the concept of megapolitans and megaregions, such as the Southwest Megaregion, comprised of the Southern California Megapolitan (including Las Vegas) and the Arizona Sun Corridor (Phoenix/Tucson). Sondra briefly described the study participants and project schedule (Aug 2012 – July 2014) and then discussed the corridor justification and draft business case, economic scenario comparison, key justifications, and outlined Study Phases 1 & 2 deliverables. Sondra the evaluation process and criteria, showed the universe of corridor alternatives and the Sondra is working with the project sponsors, neighboring states, resulting Level I recommendations. core agency partners such as MPOs in the Phoenix and Las Vegas regions as well as the federal partners, stakeholder partners, and focus groups. They have received useful input from the public meetings that were held in October 2013. Sondra stated that they are about two-thirds through the study and are currently working on the feasibility assessments for the connectivity segments and additional screening for the priority section. Draft recommendations are anticipated in March 2014. Information is also available on the website (www.ilstudy.com). The next stakeholder meetings are scheduled for January,

March and May of 2014 with a public meeting scheduled for June 2014 with the final recommendations. The update concluded. Discussion followed.

Item 4a: Discussion on Amendments, Adjustments to the FY 2014-2017 Statewide Transportation Improvement Program (STIP) document and the development of the FY 2014-2023 Transportation System Projects document (Jason Van Havel)

Jason Van Havel, Assistant Chief of NDOT Program Development stated that regarding the closeout of federal fiscal 2013, there have not been any final adjustments, modifications or amendments. They have been concentrating on developing a 2014-2017 STIP and have made a significant change in the document format. They decided to move forward with adopting the four TIPs from the MPOs by reference. Within a few days, they hope to have the final document submitted for approval. The update concluded. Discussion followed. Randy Fultz commented that when the STIP amendments are on the STTAC agenda, it would be beneficial and helpful if attachments could be provided for reference. Jason Van Havel acknowledged the request.

Item 4c: Update on Road Relinquishment (AB-18) Document (Bob Madewell)

Bob Madewell, Chief of NDOT Roadway Systems provided an update on the road relinquishments document. Assembly Bill 18 provided changes to NRS 408.527 regarding road relinquishments, required a manual be developed with the assistance of local agency input and NDOT. Bob stated that there are 29 members on the committee for road relinquishments. By the end of this week, the STTAC members will receive a draft copy of the road relinquishment document for review. Bob is requesting that the STTAC review the document and comment within a 20-day time frame. Bob will send out a list of the workshop attendees so everyone will know who is on the original committee. The update concluded. Discussion followed regarding the 20-day time frame comment period.

Item 4e: Overview of Nevada DOT Research Program (Ken Chambers)

Ken Chambers, Chief of NDOT Research provided an overview of the NDOT Research Program. Ken stated that at a previous meeting, Jim Nichols, P.E. of TMCC and Director of the Local Technical Assistance Program (LTAP), introduced himself to the STTAC and a flier was distributed to the STTAC for assistance in training or education needs. Ken commented that NDOT's Research Program is NDOT oriented but the best problem statements and issues are identified by transportation people, not the researchers or consultants. Ken anticipates that the problem statement solicitation will go out in late January or early February and if any STTAC members have any transportation related problems that may qualify as a project, to contact him or Manju Kumar in the Research Section. Ken explained the problem statement process. Once problems are identified, a middle-management committee reviews and ranks them, and while they typically receive 60-80 problem statements, they fund approximately 10%. The overview concluded. Discussion followed.

Item 4f: Update on Nevada Freight Assessment Study (Bill Thompson)

Bill Thompson of the NDOT Freight Planning Section distributed a handout, NDOT Nevada Freight Assessment Study/Nevada Freight Program Statewide and provided an update on the study. Bill discussed the requirements of MAP-21, the Freight Assessment Study and the State Freight Plan. The program overview included Phase I, reviewing existing published data, inventory freight infrastructure, and identifying freight dependent industries; Phase 2, outlining strategic direction, aligning with MAP-21 program and goals, and identifying future goods movement; and Phase 3, reviewing the existing process, identifying performance measures and developing and publishing a final report. Bill stated that a Freight Working Group was established to work in partnership for the stakeholders to provide adequate information and a Freight Advisory Committee will be created to be used continuously for the State

Freight Plan and NDOT's Freight Program. Bill explained the project timeline of 2013 with Phase I from mid-April to the end of July, Phase 2 from early June to the end of September and Phase 3 from late June to early December. They are currently at the end of Phase 3. The update concluded. Discussion followed.


