Each citizen must be recognized by the Chairman. The citizen is then to approach the microphone to state his or her name, and to spell the last name for the record. The Chairman may limit remarks, if such remarks are disruptive to the meeting or not within the NBPAB's jurisdiction.

Public comment is limited to 5 minutes per person. Agenda items may be taken out of the order presented on the agenda at the discretion of the chairperson. The Board may combine two or more agenda items for consideration. The Board may remove an item from the agenda or delay discussion relating to an agenda item at any time. The Board may make reasonable restrictions on time, place, and manner but will not restrict the comments based upon viewpoint.

5. Board Membership *Tim Rowe*

The membership of the Nevada Bicycle and Pedestrian Advisory Board is defined within NRS 408.573. All members must be appointed by the Governor. A summary of the current membership and those members nearing the end of their appointments will be given.

6. Bike Share Implementation in Southern NV *Ron Floth*

The RTC of Southern Nevada will be implementing a Bike Share Program in the urban cores of the Las Vegas Valley. Bike Share systems provide bicycles as public transportation through a system of bike share stations. An update on the current status of this initiative will be given.

7. Report on Share the Road Specialty License Plates and Grant Program

Albert Jacquez

The NBPAB developed a "Share the Road" specialty license plate to provide additional funding for local bicycle and pedestrian initiatives throughout the state. Funds are made available through a competitive grant process administered by the NDOT. Authority for the administration of the funds by the NDOT is enabled via a legal agreement with the NBPAB. An update on current status of plate sales, and a schedule for the first grant cycle, will be given.

8. Nevada Active Transportation Plan *Kristi Robusto* (for possible action)

The Nevada Department of Health and Human Services is developing an Active Transportation Plan for the state. A presentation as to its status will be given. Action may be taken to provide an advisory endorsement to the Department of Health and Human Services of the Active Transportation Plan.

9. Pedestrian Safety Projects *Ken Mammen, P.E.*

The NDOT has developed a priority list of pedestrian improvement projects for implementation on state-owned facilities. An update as to the status of these projects will be presented.

10. Strategies for Improving Conditions for Alternate Modes in the City of Las Vegas *Mike Janssen, P.E., Transportation Manager, City of Las Vegas*

The City of Las Vegas is implementing a program of improvements for bicyclists and pedestrians. This approach includes innovative strategies and designs. An overview of these improvements and strategies will be presented.

11. Park and Pedal Program *David Montague, Founder, Park and Pedal Organization*

The Park and Pedal Program focuses on utilization of bicycles for the last segment of frequent trips in combination with traditional commuting modes. An overview of the park and Pedal Program will be presented.

12. Reports From the Bicycle and Pedestrian Programs Statewide

An update of projects and initiatives being worked on by the NDOT Bicycle & Pedestrian Program will be given.

13. Board Member Reports (For possible action)

Reports from NBPAB members will be given on those activities, initiatives or issues specific to their sectors occurring since the last meeting on July 21, 2016. Particular items of interest may be agendized for a future meeting.

14. Schedule and prepare items to be placed on the next agenda (For possible action)

The next NBPAB meeting is proposed to be scheduled for November 17, 2016.
