

Nevada Department of Transportation
SB 377 Quarterly Report
April 1 to June 30, 2011

In the 2009 Legislative Session, Senate Bill 377 (SB 377) was passed into law. This allowed the Director of the Nevada Department of Transportation (NDOT) to solicit informal bids for projects with an estimated cost not in excess of \$250,000.

Per the quarterly reporting requirements contained in SB 377, this report provides the following information (refer to attached spreadsheet):

- (a) The name of the contractor to whom the contract was awarded
- (b) The amount of the contract awarded
- (c) A brief description of the project
- (d) The names of all contractors from whom bids were solicited

SUMMARY

In the period of April 1, 2011 to June 30, 2011, NDOT executed six contracts that were solicited for informal bids. For the contracts executed this quarter, twenty-seven different contractors were solicited. The number of contractors contacted on an individual solicitation varied from a minimum of three to a maximum of nine. These six contracts have a total value of \$520,672.25.

The contracted amount of projects in District I (southern Nevada) ranged from \$18,875.00 to \$79,924.25. The scope of work on the projects included:

- Fencing on concrete barrier rail on northbound I-15 on ramp
- Remove and replace damaged soundwall on I-515 southbound

The contracted amount of the projects in District II (northwest Nevada) ranged from \$28,400.00 to \$128,205.00. The scope of work on the projects included:

- Remove and replace dynamic message sign (DMS) on SR 431 Mt. Rose Highway
- Install high mast luminaire on US 395

No contracts were executed in District III (northeast Nevada) this quarter.

The contracted amount of project by Architecture Division was \$128,205.00 for the following scope of work:

- Tenant improvements at the North Annex in Carson City
