

**Nevada Department of Transportation
SB 377 Quarterly Report
April 1 to June 30, 2012**

In the 2009 Legislative Session, Senate Bill 377 (SB 377) was passed into law. This allowed the Director of the Nevada Department of Transportation (NDOT) to solicit informal bids for projects with an estimated cost not in excess of \$250,000.

Per the quarterly reporting requirements contained in SB 377, this report provides the following information (refer to attached spreadsheet):

- (a) The name of the contractor to whom the contract was awarded
- (b) The amount of the contract awarded
- (c) A brief description of the project
- (d) The names of all contractors from whom bids were solicited

SUMMARY

In the period of April 1, 2012 to June 30, 2012, NDOT executed eight contracts that were solicited for informal bids. For the contracts executed this quarter, twenty six different contractors were solicited. The number of contractors contacted on an individual solicitation varied from a minimum of one to a maximum of nine. These eight contracts have a total value of \$748,436.14.

The contracted amount of projects in District I (southern Nevada) ranged from \$71,590.00 to \$126,415.00. The scope of work on the projects included:

- Remove and replace crushed RCP under Valley View Blvd. on-ramp to US 95 NB MP 77.80
- Remove and replace permanent overhead sign and bridge rail on I-934 Bridge on I-15 NB over SR159, Charleston Blvd.

The contracted amount of the project in District II (northwest Nevada) was \$167,007.00 for the following scope of work:

- Remove and replace cattle guards and cattle guard wings; 2 in. cold milling and 2 in. plantmix bituminous surface

The contracted amount of the project in District III (northeast Nevada) was \$54,648.00 for the following scope of work:

- Removal and replacement of substandard guard rail on SR227 at structure B487 at Lamoille Creek and on SR226 at structure B685 at Deep Creek

The contracted amount of projects by Architecture Division ranged from \$49,000.00 to \$175,690.00. The scope of work on the projects included:

- Rehabilitate the RFG Tank in the Sparks Equipment Yard
- Residential re-roofs at two residences at the Quinn River Maintenance Station
- Well drilling at the Trinity Rest Area
- Rest area improvements located at Cosgrave Rest Area
