Nevada Department of Transportation SB 377 Quarterly Report Through September 30, 2010

In the 2009 Legislative Session, Senate Bill 377 (SB 377) was passed into law. This allowed the Director of the Nevada Department of Transportation (NDOT) to solicit informal bids for projects with an estimated cost not in excess of \$250,000.

Per the reporting requirements contained in SB 377, this report provides the following information:

- (a) The name of the contractor to whom the contract was awarded
- (b) The amount of the contract awarded
- (c) A brief description of the project
- (d) The names of all contractors from whom bids were solicited

SUMMARY

In the period of July 1, 2009 to September 30, 2010, NDOT executed eight contracts that were solicited for informal bids. Thirty-two different contractors were solicited on these contracts, which had a total value of \$555,552. The number of contractors solicited on an individual solicitation varied from a minimum of three to a maximum of eight. Only contracts executed before October 1, 2010 are reported herein.

The contracted amount of projects in District I (southern Nevada) ranged from \$16,900 to \$39,388. The scope of work on the projects included:

- Construction of a driveway on Blue Diamond Road (State Route 160)
- Extending concrete barrier rail on Interstate 15 near Sahara Avenue
- Two separate projects to erect structures to weather-protect ice and snow removal materials at NDOT maintenance yards located at Mountain Springs (State Route 160) and Mount Charleston (State Route 157)

The contracted amount of projects in District II (northwest Nevada) ranged from \$28,950 to \$163,163. The scope of work on the projects included:

- Access management improvements on Kietzke Lane (State Route 667)
- Installing flashing "Falling Rock" signs on US 95 by Walker Lake
- Installing a right turn pocket at South Meadows Parkway and the northbound US 395 onramp

The contracted amount of the project in District III (northeast Nevada) was \$202,130. The scope of work on the project was:

• Replace a right-of-way fence on US 93 in Elko County.
