Nevada Department of Transportation SB 377 Quarterly Report October 1, 2011 to December 31, 2011

In the 2009 Legislative Session, Senate Bill 377 (SB 377) was passed into law. This allowed the Director of the Nevada Department of Transportation (NDOT) to solicit informal bids for projects with an estimated cost not in excess of \$250,000.

Per the quarterly reporting requirements contained in SB 377, this report provides the following information (refer to attached spreadsheet):

- (a) The name of the contractor to whom the contract was awarded
- (b) The amount of the contract awarded
- (c) A brief description of the project
- (d) The names of all contractors from whom bids were solicited

SUMMARY

In the period of October 1, 2011 to December 31, 2011, NDOT executed fifteen contracts that were solicited for informal bids. For the contracts executed this quarter, thirty different contractors were solicited. The number of contractors contacted on an individual solicitation varied from a minimum of one to a maximum of six. These fifteen contracts have a total value of \$1,792,465.81.

The contracted amount of projects in District I (southern Nevada) ranged from \$26,200.00 to \$99,718.42. The scope of work on the projects included:

- Repair embankment slope and install drainage outlet protection at I-515 / US95 interchange, Henderson, NV
- Replace concrete bridge rail on I-15 southbound over Industrial Rd.
- Culvert cleaning on SR 160 Blue Diamond Rd., MP CL 22.18 to CL 37.39 and US 95 Searchlight, MP CL 44.96 in Clark County, NV

The contracted amount of the projects in District II (northwest Nevada) was \$28,855.00 for the following scope of work:

 Install 9.80 lane miles of center line rumble strips US 50 MP CC 15.0 to MP CC 16.6 / LY 0.0 and US 50 MP CC 16.6 / LY 0.0 to MP LY 3.0

The contracted amount of project in District III (northeast Nevada) ranged from \$24,400.00 to \$294,999.00. The scope of work on the projects included:

- Adjust road grades, remove and replace cattle guard at Montello Railroad Crossing
- Cold mill the existing plant mix surfacing and repave on US93 at EL MP 82.16, 84.65 and 92.57 in Elko County, NV
- Construct a 150' X 300' salt sand pad with two Type 2 driveway approaches on US93 at MP EL 97.0
- Overhead door maintenance, repair and replacement in Elko County, NV

The contracted amount of projects by Architecture Division ranged from \$28,825.00 to \$195,007.00. The scope of work on the projects included:

- Elevator upgrades, ADA ramp / parking lot improvements at District II HQ
- Overhead door remodel at Ruby Valley Maintenance Station
- Overhead door replacement at Elko Maintenance Station
- Fence replacement at Incline Village Maintenance Station
- Drainage mitigation at US93 and Lakeview
- Paving and striping a parking expansion at HQ
- Mill and fill south parking arena at HQ
