**What is the Kietzke Lane Safety Management Plan?**

The Kietzke Lane Safety Management Plan is a study that examines the safety issues and concerns on Kietzke Lane. As a result of the study, the Nevada Department of Transportation (NDOT) has made recommendations for improvements on this road that will enhance safety for all road users.

The study evaluated the safety issues on Kietzke Lane, from Galletti Way to South Virginia Street (see map on the back). After a thorough evaluation and input from the public, NDOT is now proposing short-term and long-term safety improvements to this section of Kietzke Lane.

NDOT is seeking your input on the proposed improvements, many of which will affect anyone who lives, works or travels this corridor. Proposed improvements include:

- *Bicycle safety improvements that may include the removal of on-street parking*
- *Pedestrian safety improvements including sidewalks, lighting and pedestrian crossings*
- *Americans with Disabilities Act (ADA) improvements that may include sidewalk widening into parking areas*
- *Intersection safety improvements that may include raised medians and roundabouts*

**Why was this study needed?**

This corridor currently has a number of safety concerns, and NDOT is working to improve these issues so that pedestrians, bicycles and vehicles can all safely share the road. One of NDOT's major goals is to improve the safety of our state's major roads; Kietzke Lane is a major focus of the department's safety improvement initiative. If you walk, bike or drive this road, you can agree that Kietzke Lane is a busy road, and improvements must be implemented in order to enhance the safety of everyone who uses this road.

**How long will it take to implement these proposed improvements?**

At this point, these are proposed improvements. After review and input from residents, stakeholders, and participating agencies, NDOT will finalize the list of prioritized recommendations for the corridor. Implementing these recommendations will be based on the degree of safety improvement and available funding.

**What can I do to help this study?**
