Widening of US 95 to add one general purpose lane, one auxiliary lane in each direction from Durango Drive to Kyle Canyon Road, and HOV drop ramps on US 95 at Elkhorn Road beginning early 2017



Construction of new interchange at Kyle Canyon Road beginning early 2017

Landscape and aesthetic improvements will be made at each phase location.
