Introduction:

The State of Nevada enacted the Nevada Administrative Procedure Act in 1965. Section 6 of that Act became codified as NRS 233B.050 and required, in part, that all state agencies "[a]dopt regulations of practice, setting forth the nature and requirements of all formal and informal procedures available, including a description of all forms and instructions used by the agency." In 1977, the Legislature amended that text to state "[a]dopt rules of practice" rather than "regulations of practice." Due to the absence of any legislative history addressing this particular text in either the 1965 or the 1977 Sessions, we do not have any clear legislative direction as to the significance of this change from the term "regulations" to "rules."

However, the definition of the term "regulation" pursuant to NRS 233B.038 includes "[a]n agency rule . . . which effectuates or interprets law or policy, or describes the organization procedure or practice requirements of any agency." Therefore, agencies are required to adopt rules of practice which effectuate or interpret law or policy, or describe their organization procedure or practice requirements. Chapter 233B of NRS sets forth the procedure for adoption of regulations, including those pertaining to an agency's rules of practice. Once adopted, agencies are required pursuant to NRS 233B.050(1)(b) to make its regulations available for public inspection. As a result, the Department has identified those regulations contained herein as its Rules of Practice.

Those items that are not considered to be included as Rules of Practice include the following items:

- a. Statements concerning only the internal management of the Department that do not affect the private rights or procedures available to the public.
- b. Manuals of internal policies and procedures of the Department used solely to train or guide employees and not used as authority to determine a person's compliance with federal or state statutes or regulations.
- c. Provisions of federal law, regulations or guidelines.
- d. Regulations concerning the use of public roads or facilities which is indicated to the public by means of signs,

signals, or other traffic control devices that conform to the MUTCD.

During the 1979 Session, the Legislature amended NRS 233B.050 by adding the following requirement for each state agency:

Review its rules of practice at least once every 6 years and file with the secretary of state a statement setting forth the date on which the most recent review of those rules was completed and describing any revisions made as a result of the review.

This requirement remained unchanged until the 1995 Session when the Legislature amended this text to change the reporting period from 6 years to 3 years as it remains today. To meet this statutory requirement, the Department shall maintain these Rules of Practice and monitor any proposed and adopted revisions to such Rules. Once every three (3) years beginning on January 1, 2013, the Department shall submit a letter to the Secretary of State including a Table of those regulations contained in its Rules of Practice and describing any proposed or adopted revisions to such Rules. See Secretary of State letter attached hereto as Exhibit 1.

The intent of this transmittal is to file with the Secretary of State the Nevada Department of Transportation's (the "Department") statement setting forth the date on which its most current review of its Rules of Practice was completed and describing any revisions made as a result of such review in accordance with NRS 233B.050(1)(d).

The Department completed its review of its Rules of Practice effective January 1, 2013. The Department is providing the Secretary of State with a Table of its Rules of Practice listing all of the regulations it has adopted as part of its Rules of Practice. The Department found that sections NAC 408.650 through 408.696, inclusive, were added to the regulations effective April 20, 2010 creating a new Transportation Facilities segment in NAC Chapter 408. Those regulations were adopted pursuant to NRS 408.548(2) pertaining to the solicitation of proposals for public-private partnerships for transportation facilities. The Department's next review of its Rules of Practice is scheduled to be completed on January 1, 2016.
