**Pedestrian safety improvements along Boulder Highway (for possible action)** *Lori Campbell – NDOT Safety Engineering*

A series of pedestrian safety improvements along Boulder Highway will be discussed. Eight intersections are expected to be reconfigured, between Fremont Street in downtown Las Vegas and Racetrack Road in Henderson. Action may be taken to provide an advisory endorsement of the proposed improvements.

**6. 2017 Nevada Bicycle and Pedestrian Summit** *Bill Story & Ron Floth*

The Nevada Bicycle and Pedestrian Summit is an annual Summit on issues affecting bicyclists and pedestrians. The location for the 2015 Summit is proposed for fall 2017 in Southern Nevada. A summary of summit coordination will be discussed.

**7. Report on Share the Road Specialty License Plates and Grant Program**

*Albert Jacquez – Bicycle/Pedestrian Safety Information and Outreach Coordinator*

The NBPAB developed a “Share the Road” specialty license plate to provide additional funding for local bicycle and pedestrian initiatives throughout the state. Funds are made available through a competitive grant process administered by the NDOT. Authority for the administration of the funds by the NDOT is enabled via a legal agreement with the NBPAB. An update on current status of plate sales, and status of the first grant cycle, will be given.

**8. Report from the 2017 National Bicycle Summit held in Washington D.C.** *Ron Floth & Ben Taylor*

The NDOT funded NBPAB members to attend the 2017 National Bicycle Summit held on March 6-9, 2016, in Washington D.C. A report of what new items and issues of national interest were presented at the summit will be given.

**9. Report on Federal Surface Transportation Program (formally Transportation Alternatives Program) funding update.** *Bill Story – Multi-modal Planning*

The Federal Highway Administration (FHWA) makes discretionary funding available to states which can be used for bicycle and pedestrian related projects and programs. These funds are available to local entities via competitive state funding programs. An update on the selected projects for the 2016-2018 funding cycle will be presented.

- 10. Report on Recreational Trails Program funding update.** *Janice Keillor*  
The Federal Highway Administration (FHWA) makes discretionary funding available to states which can be used for recreational and trail projects and programs. These funds are available to local entities via a competitive state funding program administered by the Nevada Division of State Parks. An update on the selected projects and the latest funding cycle will be presented.
- 11. Status of the State Comprehensive Outdoor Recreation Plan (SCORP).**  
*Janice Keillor – State Parks*  
The SCORP is developed by the Division of State Parks to identify trends and propose goals for Nevada’s outdoor recreation. An update as to the status of the SCORP will be presented.
