Nevada Department of Transportation SB 377 Quarterly Report October 1 to December 31, 2010

In the 2009 Legislative Session, Senate Bill 377 (SB 377) was passed into law. This allowed the Director of the Nevada Department of Transportation (NDOT) to solicit informal bids for projects with an estimated cost not in excess of \$250,000.

Per the quarterly reporting requirements contained in SB 377, this report provides the following information (refer to attached spreadsheet):

- (a) The name of the contractor to whom the contract was awarded
- (b) The amount of the contract awarded
- (c) A brief description of the project
- (d) The names of all contractors from whom bids were solicited

SUMMARY

In the period of October 1, 2010 to December 31, 2010, NDOT executed nine contracts that were solicited for informal bids. For the contracts executed this quarter, twenty-six different contractors were solicited. The number of contractors contacted on an individual solicitation varied from a minimum of three to a maximum of nine. These nine contracts have a total value of \$1,073,659.00.

The amount of award for District I (southern Nevada) informal bid projects ranged from \$6,750.00 to \$214,180.00. The scope of work on the projects included:

- Repair of bridge superstructure on Tropicana Avenue bridge over I-15
- Installing ADA ramps at Rancho Road and Lone Mountain Road
- Drainage pipe repair on Charleston Boulevard (State Route 159)
- Mill and fill asphalt pavement at the bridge approach to Carey Avenue over I-15
- Install chain link fence at bridge abutment of I-15 interchange at D Street.

The contracted amount of projects in District II (northwest Nevada) ranged from \$57,775.00 to \$173,000.00. The scope of work on the projects included:

- Glare screen installation on Pyramid Highway (State Route 445)
- Slope revegetation on Gonowabie Road at Lakeshore Boulevard (State Route 28)

The contracted amount of projects in District III (northeast Nevada) ranged from \$228,000.00 to \$242,999.00. The scope of work on the projects included:

- Construction of a salt sand pad on US 93 in Elko County
- Repair of a section of State Route 892 in White Pine County
