- 3. PUBLIC COMMENT AND CITIZENS PARTICIPATION:** No action may be taken on any matter discussed under this item that is not listed on this Agenda, although the NBPAB can direct that such items be placed on a future agenda.

At this time, any citizen in the audience may address the NBPAB on any matter. No vote can be taken on a matter not listed on the posted agenda; however, the NBPAB can direct that the matter be placed on a future agenda.

Each citizen must be recognized by the Chairperson. The citizen is then to approach the microphone to state his or her name, and to spell the last name for the record. The Chairperson may limit remarks if such remarks are disruptive to the meeting or not within the NBPAB's jurisdiction.

The Nevada Department of Transportation keeps the official record of all proceedings of the meeting. In order to maintain a complete and accurate record, copies of documents used during a presentation must be submitted to the Recording Secretary.

The Nevada Bicycle and Pedestrian Advisory Board appreciates the time citizens devote to be involved in this important process.

Public comment is limited to 5 minutes per person.

Agenda items may be taken out of the order presented on the agenda at the discretion of the chairperson. The Board may combine two or more agenda items for consideration. The Board may remove an item from the agenda or delay discussion relating to an agenda item at any time. The Board may make reasonable restrictions on time, place, and manner but will not restrict the comments based upon viewpoint.

4. **Approval of the July 20th, 2017 minutes (for possible action)**
Action may be taken to approve the July 20th, 2017 meeting minutes.

General Meeting Items.

Presentations are limited to 10 minutes per presenter.

5. **2017 Nevada Bicycle and Pedestrian Summit (for possible action)** *Keely Brooks*

The Nevada Bicycle and Pedestrian Summit is an annual Summit on issues affecting bicyclists and pedestrians. The 2017 Summit is scheduled for November 13 & 14, at the Suncoast Hotel & Casino in Las Vegas. A summary of summit coordination will be discussed. Action may be taken to provide additional ideas in planning for the Bicycle and Pedestrian Summit.

6. **Report on Share the Road Specialty License Plates and Grant Program (for possible action)** *Albert Jacquez*

The NBPAB developed a "Share the Road" specialty license plate to provide additional funding for local bicycle and pedestrian initiatives throughout the state. Funds are made available through a competitive grant process administered by the NDOT. Authority for the administration of the funds by the NDOT is enabled via a legal agreement with the NBPAB.

7. **Presentation from Zero Teen Fatalities**

The Zero Teen Fatalities program strives to put an end to traffic-related, teen deaths by educating young drivers about the importance of being safe behind the wheel.

8. **Pedestrian Zone guidance status** *Albert Jacquez*

The Pedestrian Safety Zone is a law (NRS 484B.135) that went into effect October 1, 2015. NBPAB will provide the status of pedestrian safety zones in which fines are doubled for speeding, as is already done in construction zones.

9. **Review of Bike/Ped Accident/Injury Data** *Ken Mammen*

The Office of Traffic Safety compiles statistics on crashes, highway deaths, and DUIs within Nevada. Among its many publications is the weekly Fatality Analysis Reporting System (FARS). An update of the latest FARS report will be given. A map of bicycle-related crashes will be presented.

10. **Report from the 2017 National Walking Summit** *Ron Floth*

The National Walking Summit is a walking summit held in North America annually. The Summit was held September 13-15, 2017 in St. Paul, Minnesota. A report of any new items and issues of national interest that were presented at the summit will be given.

11. **Crash reporting cards for bicyclist and pedestrians** *Albert Jacquez*
This is a card for bicyclists or pedestrians who have been involved in a crash with a driver or a cyclist. This is a form to remind the cyclist or pedestrian what information to record, such as license plate number, witness information, driver/cyclist information (name, phone, insurance info, etc), time of incident, and location.
12. **Reports from the Bicycle and Pedestrian Programs Statewide**
An update of projects and initiatives being worked on by the NDOT and the two large Metropolitan Planning Areas will be given.
13. **Board Member Reports**
Reports will be provided from NBPAB members on activities, initiatives or issues specific to their sectors occurring since the last meeting on July 20th, 2017.
14. **Schedule and prepare items to be placed on the next agenda (For possible action)** The next NBPAB meeting is proposed to be scheduled for November 2017. The Board may decide to hold the meeting in conjunction with the 2017 Bicycle Pedestrian Summit, November 13 & 14, in Las Vegas. Items of interest to NBPAB may be agendized for a future meeting, including items mentioned during the Board Member Reports.
